

Your Electric Bill

Irrigation metering is different than other metering in the system. Because it is seasonal usage, it is billed according to demand and usage rather than according to a flat monthly fee plus usage.

- This date indicates the **due date for current charges**. If payment is not received after 15 days past billing date, a past due notice is mailed and service is subject to disconnect.
- This number is your **meter number**. It is linked in our office with your location. When reporting a power outage or service problems, this number is most helpful to our dispatcher and line crews.
- These numbers and/or words are your **location description**. (i.e., southeast sprinkler or well 21, etc.)
- Your electric energy usage is measured in kilowatt-hours, or kWh (1000 watts = 1 kilowatt). The dates of your meter readings are recorded here as well as the previous and present readings. The difference between these two readings measures how many kilowatt hours were used that month.
- This denotes your current kW reading and monthly kW charge (demand). Your monthly demand is your peak kW demand for that month. When your irrigation system is running, it is establishing a demand reading. It measures the highest demand or load put on the system each month.
- If you are on our Irrigation Rate, you have a facilities charge, or monthly base amount charged for providing electric service. This line item is billed during the months of April through September and is a flat fee of \$100.00 per month.
- This is your rate class code. You may refer to the MCREA rate sheet to determine your electric rate.
- Each month, a bill message is included on the statement. The message is an alert to safety issues, events, or other information for MCREA members.
- Additional information about your average daily electrical use and average daily cost is provided at the bottom of each bill.
