## Morgan County REA Returns \$2.5 Million to Members

It's time for you to get the credit — capital credits, that is — for helping build, sustain and grow your local electric cooperative. This year, Morgan County Rural Electric Association's board of directors has approved a patronage capital retirement of \$2.5 million to those who were members of the cooperative in the years 1998, 1999, 2000, 2001, 2003, 2004 and 2005.

When you signed up to receive electric service from Morgan County REA, you became a member of an electric cooperative. While investor-owned utilities return a portion of any profits back to their shareholders, electric co-ops operate on an at-cost basis. So instead of returning leftover funds, known as margins, to folks who might not live in the same region or even the same state as you do, MCREA allocates and periodically retires capital credits (also called patronage capital) based on how much electricity you purchased during a year.

At their regular meeting on October 22, 2018, the Morgan County REA Board of Directors authorized patronage capital retirements totaling \$2.5 million for a complete retirement of 2003 and 2004 and partial retirement of 2005 MCREA allocations, along with a complete retirement of 1998, 1999 and 2000 and partial retirement of 2001 generation and transmission margin allocations. This year's retirement is one-half million dollars more than the 2017 and 2016 patronage capital retirements, which came in at \$2 million each year.

This means members from those years will be sent a capital credits check in the mail this month, reflecting their contribution of capital to, and ownership of, the cooperative during those years. That may seem like a long time ago. However, those funds helped us manage rates, reduced the amount of money we needed to borrow from outside lenders to build, maintain and expand a reliable electric distribution system and covered emergency expenses.



## Frequently Asked Questions About Capital Credits

### What is patronage capital (capital credits)?

MCREA annually “allocates” to each member, based upon the member's purchase of electricity, operating revenue remaining at the end of the year; later, as financial condition permits, these allocated amounts—capital credits—are retired. Since a cooperative's members are also the people the co-op serves, capital credits reflect each member's ownership in, and contribution of capital to, the cooperative.

### Where does the money come from?

Member-owned, not-for-profit electric co-ops set rates to generate enough money to pay operating costs, make payments on any loans, and provide an emergency reserve. At the end of each year, we subtract operating expenses from the operating revenue collected during the year. The balance is called an operating “margin.”

### How are margins allocated?

Margins are allocated to members as capital credits based on their purchases from the cooperative—how much power the member used. Member purchases may also be called patronage.

### I didn't receive electric service from Morgan County REA in those years. Will I get any retirement?

No. Capital credit retirements will only be made to members who purchased electricity in the designated retirement years.

### What if I've moved or didn't receive a capital credits check?

If you move or no longer have electric service with Morgan County REA, it is important that you keep the cooperative informed of your current address, so that retirements can be properly mailed to you. If you purchased electricity during the years being retired, then you are entitled to a capital credit retirement, even if you move out of MCREA's service area. ## Wickstrom Earns Board Leadership Certification

Morgan County Rural Electric Association Board of Directors Vice President Cary L. Wickstrom was among the 22 directors from Colorado's electric cooperatives receiving their Credentialed Cooperative Director certification or Board Leadership certificates from the National Rural Electric Cooperative Association.

Wickstrom received the Board Leadership certificate in September for adding to his knowledge of the electric industry and completing a specific schedule of classes. Today's electric utility environment imposes many demands on electric cooperative directors, particularly the need for increased knowledge of changes in the electric utility business, new governance skills and a working knowledge of the cooperative principles.

The NRECA Credentialed Cooperative Director, or CCD, program requires

attendance and demonstrated understanding of the core competencies contained in five courses: director duties and liabilities; understanding the electric business; board roles and relationships; business planning; and understanding financial planning. The NRECA Board Leadership program is for directors who earn their CCD certification and complete 10 additional credits in advanced, issues-oriented courses.

The next step for directors who have earned their CCD and BL certificates is the NRECA Director Gold credential. The Gold credential recognizes directors committed to continuing their education beyond the CCD and BL and who desire a credential that demonstrates their ongoing commitment to advancing their knowledge and performing their fiduciary duty.
