

MCREA MAIL-IN **BALLOTS FOR** DIRECTOR ELECTION

Mail-in ballots were sent to the MCREA membership on February 14, 2018 for the upcoming director elections to be held at the MCREA Annual Meeting on March 17, 2018. The mail-in ballots must be returned to Morgan County REA headquarters no later than 5 p.m. on Friday, March 16, 2018.

As per state law, once a mail-in ballot has been received, that member is not allowed to change their vote, either by another mail-in ballot or by voting in person at the annual meeting. Those members who choose not to vote by mail-in ballot may still cast their vote in person at the annual meeting.

MEET MCREA'S CANDIDATES FOR BOARD DIRECTOR

These five candidates have submitted petitions to serve on the Morgan County REA Board of Directors. Board elections will take place at the MCREA Annual Meeting on March 17, 2018. Here is background information on each of the candidates.

CARY L. WICKSTROM | DISTRICT I



Cary L. Wickstrom from Orchard is currently serving as a Director from District I. He has been a member of the MCREA Board of Directors since 2011 and has earned the Credentialed

Cooperative Director certification from the National Rural Electric Cooperative Association.

Wickstrom is self-employed in a diversified farming, ranching and cattle feeding operation. Raised in this area, Cary is a graduate of Colorado State University with a degree in Agricultural Business. While attending CSU, he was a member of Farmhouse Fraternity. Wickstrom is not new to the cooperative business model, having served on the boards of the Wiggins, Horizon, and M & M co-op boards. Cary helped start and was the first president of the Colorado Conservation Tillage Association, is a past board member and president of the Colorado Wheat Administrative Committee and has served on the U.S. Wheat Board. In addition to the MCREA board, he is currently a member of the Farm Bureau, Colorado Livestock Association, CSU Ram Club, and the CSU Beef Club. Wickstrom has also served on the Weldon Valley School District Board of Education.

Wickstrom has two daughters, Leigha and Tara, and lists time with his family and friends, travel, snow and water skiing as hobbies and interests.

TERRY W. TORMOHLEN | DISTRICT 2

Terry Tormohlen is seeking his first term on the Board of Directors for Morgan County REA. Terry is Owner/Operator of Countryside Pullets LLC located south of Fort Morgan, a contract chicken

grower for Opal Foods in Roggen.



Terry has been a member and Past President of Colorado Egg Producers for more than 20 years, and is currently serving as Secretary/Treasurer for the organization. He was also appointed by the Secretary of Agriculture to serve on the Colorado Foundation for Agriculture Committee. She will be completing her second term as commissioner this December, and due to term limitations will not be seeking re-election.
