UNCLAIMED & UNCASHED CAPITAL CREDITS

In November 2017, the Morgan County REA Board of Directors authorized patronage capital retirements totaling \$2 million for a complete retirement of 2001 and 2002 MCREA allocations, along with a complete retirement of 1996 and 1997 and partial retirement of 1998 generation and transmission margin allocations. In December, members from those years were sent a capital credits check in the mail reflecting their contribution of capital to, and ownership of, the cooperative during those years.

It is not unusual for MCREA to have unclaimed or uncashed capital credits checks from margin allocations. In some cases,

letters containing refunds were returned due to lack of current address. MCREA also has instances in which capital credits checks were never cashed.

If you have not received a capital credits check and you were a Morgan County REA member in 1996, 1997, 1998, 2001 or 2002, please contact us to verify that we have your current address to ensure that your capital credits check finds you. RANDY GRAFF EARNS DIRECTOR GOLD DESIGNATION

Morgan County Rural Electric Association Board of Directors President Randy Graff recently attained the Director Gold certification from the National Rural Electric Cooperative Association. The Director Gold (DG) designation is the final step in

the rigorous cooperative director certification process from the national electric cooperative organization. Graff completed the Credentialed Cooperative Director (CCD) and Board Leadership (BL) certifications prior to receiving the DG recognition in October.

To earn the CCD certificate, directors must complete five core courses that demonstrate competencies in industry knowledge, board member responsibilities and financial management. The BL certificate recognizes individuals who continue their professional development after becoming a CCD and complete 10 additional credits in advanced, issues-oriented courses. An electric cooperative director must complete the CCD and BL certifications and take an additional three board leadership courses to earn DG designation.

Today's electric utility environment imposes many demands on electric cooperative directors, particularly the need for increased knowledge of changes in the electric utility business, new governance skills and a working knowledge of the cooperative principles.

A total of seven Morgan County REA directors have attained the CCD certification, with five MCREA directors earning the BL certificate and four achieving the DG status.

COLTON UNREIN ACHIEVES JOURNEYMAN LINEMAN CERTIFICATION

Morgan County REA is proud to announce that MCREA Lineman Colton Unrein completed the certification process to become a certified journeyman lineman. Attaining the journeyman designation is referred to by linemen as “cracking out.”

Unrein graduated from Brush High School in 2012 and was a recipient of the Morgan County REA lineworker scholarship. He attended Western Nebraska Community College, graduating from powerline school in 2013. Before coming on board with Morgan County REA in February 2014 as an apprentice lineman, Unrein worked for CPI in Sedalia, Colorado, and Bird Electric in Midland, Texas.

To achieve journeyman certification, Unrein had to complete an extensive battery of books and tests, log 8,000 hours on the job and pass a written and field test administered by Morgan County REA.

vehicles. We are looking to update that list with existing and new volunteers.



MCREA CONDUCTING POLE INSPECTIONS

Morgan County REA is continuing to conduct pole inspections in our service territory, utilizing independent third-party contractors. The independent contractors began inspecting MCREA's electric poles in December and will be running their inspections through March. These crews will be seen on four-wheelers around MCREA poles and infrastructure and are authorized by MCREA to conduct their inspections.

Please review this map of areas where the independent contractors will be inspecting poles. The highlighted lines indicate where inspections will take place. A map showing inspection areas in full color can be found on MCREA's website (www.mcrea.org). Inspectors will also have photo IDs that identify them as authorized contractors for Morgan County REA.

Lineworker Scholarship Application Deadline Coming Soon

Morgan County Rural Electric Association is once again proud to offer up to two lineworker scholarships to assist individuals in establishing a career in the power industry. This year, Morgan County REA is looking to award \$7,500 in scholarships for students to attend powerline school the following fall.

Qualified applicants must reside within the boundaries of Morgan County REA's service area and attend or will attend an approved lineworker training program as a full-time student. MCREA's service area boundary in northeastern Colorado includes all of Morgan County and portions of Logan, Weld, Adams, Arapahoe and Washington counties.

Scholarship recipients are selected by a committee comprised of members of the MCREA operations department. The committee's decisions are based on a number of factors, including academics, school and community participation, work experiences and a student statement of goals and aspirations. In addition to the application, candidates will be required to participate in an interview process prior to selection for the scholarship. Scholarship recipients are not required to work at Morgan County REA after graduating lineworker school. There are no age restrictions to apply for a lineworker scholarship.
